## **2005 IRS 990 Schedule A**

Line 3a Scholarship applications are received and checked for completeness by the USAWOA staff. Each application is placed in an individual folder and filed for processing.

A committee is composed of senior warrant officer assigned to the US Army Human Resources Division is recruited to review and evaluation each application. Individuals are not eligible to serve on the committee if they are in any way related to the applicants.

Approximately two weeks after the cut off date these applications are turned over to an independent selection committee for review, and sequencing in an Order of Merit list. This list is then returned with the applications to the Foundation Executive Director.

Based on the Board of Directors decision as to how many scholarships may be awarded in that cycle the Executive Director prepares or has prepared letters advising each of the awardees that they were selected and requesting that they completed an enclosed form and return it to the foundation as soon as possible. This form requests full information regarding the name, address, telephone number of the Financial Assistance Section, the individual's student identification number regarding the educational institution they are enrolled in.

When that form is received a letter to that institution advising them that the scholarship has been awarded, the acceptable use of the funds (tuition, books, lab fees, room, and board ) and asking them to deposit the funds in the student's account. At not time are funds provided to the applicant.
