The agreement calls for **mutual recognition and visibility** between the two organizations. AUSA will feature USAWOA's name, logo, and a brief description on its Association Partner webpage https://www.ausa.org/association-partners while USAWOA provides reciprocal visibility on our website https://usawoa.org/about/partners.html.

While the term "partner" appears throughout the agreement, the relationship between USAWOA and AUSA is one of **mutual respect and independent collaboration**. The organizations remain separate entities, each responsible for its own operations and advocacy priorities. Neither organization endorses the other in a commercial or political sense; rather, this partnership reflects a shared mission to support the Army and its people. Participation in the Association Partner Program comes at **no cost** to either organization, with each party covering its own expenses related to the partnership's activities.

Member Communication and Awareness

As part of this renewal, we are formally re-introducing AUSA to our members to highlight AUSA's mission and the specific benefits now available to USAWOA members. New members joining USAWOA will also receive this information, ensuring that everyone is aware of the resources at their disposal. Importantly, any member can **opt out** of AUSA membership if desired by contacting hq@usawoa.org.

Data Sharing and Commitment to Confidentiality and Security

To provide these benefits efficiently, USAWOA will securely share member contact information with AUSA (excluding those who opt out). This information may include name, mailing address, email, phone number, and military connection status. USAWOA will update this data quarterly for new and renewing members.

Both organizations remain committed to protecting members' privacy and ensuring compliance with applicable laws and recognize the importance of safeguarding members' information. All shared contact details are considered confidential and will be used exclusively for delivering the benefits outlined in this agreement. Once a USAWOA member is enrolled in AUSA, AUSA treats that individual's information the same way it treats all its members' data—according to its own privacy and confidentiality policies.

AUSA Membership for USAWOA Members

Under this agreement, every USAWOA member whose information is provided will receive a **complimentary AUSA digital Individual Membership** which includes:

- **Affiliation** with a local AUSA chapter where available.
- Professional development resources and select premium member benefits.
- Networking opportunities across AUSA's national and local events.
- **Visibility and voice** within one of the Army's most influential advocacy organizations
- Access to select premium member benefits such as discounts, professional development resources, and affinity programs.
